**APPEAL**

The Election Commission of India has announced the Schedule for Special Summary Revision of Photo Electoral Rolls with reference to 01.01.2020 as the qualifying date with a view to prepare an error free and healthy electoral rolls. The focus of this exercise will be on registration of all eligible persons especially youth, females and other marginalized section of the society beside verification of the entries of already enrolled voters to prepare an error free and healthy electoral roll.

The Schedule of SSR 2020 will commence from 01.09.2019. A massive campaign will be launched from 01.09.2019 to 15.10.2019 to verify the entries of already enrolled voters by conducting House to House (H2H) survey by BLOs to ensure an error free and healthy electoral roll. Thereafter, publication of integrated draft Electoral Roll will be done on 15.10.2019. The eligible electors can file their claims and objections from 15.10.2019 to 30.11.2019. The Draft Electoral Roll so published will be available to electors with concerned BLOs, AEROs, ERO, DEOs and also uploaded on CEO's website. The claims and objections will be disposed off by 15.12.2019 by concerned AEROs/ERO, so that final e-roll can be published on 01.01.2020.

In order to have hassle free verification and enrolment, the general public are requested to use "Voter Helpline" Mobile App, or National Voters Service Portal (NVSP), or visit Common Service Centres (CSCs) of their area, or visit Voter Facilitation Centre at ERO/AEROs Office and can call Voter Helpline (1950) for any help and assistance. They may also have details of their particulars and Forms 6, 6A, 7, 8 and 8A from BLOs. The required number of BLOs/Designated Officers are appointed in all Polling Stations of 26 – Andaman & Nicobar Islands Parliamentary Constituency to guide the people to verify their particulars and fill up the forms for inclusion of names, deletion of names, correction in particulars and changing of polling stations. The detailed list of appointment of all BLOs is available to general public on CEO's website. All the recognized political parties have been requested to appoint Booth Level Agents (BLAs) for facilitating the objective of error free and healthy rolls.

I, therefore, appeal to the general public especially the youth in the age group of 18-19 years and left out electors to enroll their name in the Parliamentary Photo Electoral Rolls and also to already enrolled voters to verify their entries in Electoral Rolls within the prescribed time frame so as to achieve 100% error free and healthy electoral rolls. I also request to all political parties, members of Press/ Media to extend their full cooperation in the exercise.
